# **Editor's Corner:**

After a somewhat gentle winter, I was ready to attack the weeds in my garden. I find weeding hard work but therapeutic. My mind can work on other stuff while I am doing it.

I have this obnoxious grass that loves to spread all over the garden. It has these roots that shoot out and downward and spread like crazy. If I just pull out the grass at the surface, they reappear in no time. I have to dig deeper and pull with a good deal of effort to get the roots removed. I also find that sometimes I inadvertently "weed out" some of the good stuff in the garden.

All this reminds me of working on this spiritual program of recovery. New to Al-Anon, I dove into the idea of considering myself and my needs first. Surely taking care of everyone around me to my detriment needed to be weeded out. I forgot about taking anyone else's needs into consideration. I had swung too far in the direction of killing this tendency, rather than tempering it. This wasn't really a defect of character, but rather, a good characteristic carried to an extreme and unbalanced point.

The defects of character that I want to be rid of are attitudes and behaviors that keep me stuck in my old ways and my stinking thinking. They inhibit my growth. These have very deep roots and seem difficult if not impossible to remove completely. I have to be constantly vigilant. When I am under stress, they like to sneak up to the surface and sometimes run rampant. They are old comfortable ruts. They grow easily but choke out the life of anything around them.

Al-Anon gives me a spiritual program. By practicing this program I become aware of what I am feeling, of what my needs are, of what is going on in my immediate world and what needs attention.





- Our Area Delegate will be giving her report on the World Service Conference. GRs are encouraged to bring one or more Al-Anon friends with them to the Assembly to here her report and learn more about service beyond the group level. All members of Al-Anon/Alateen are welcome and have a voice at the Assembly (although only the Group Representative, Alternate, or Proxy\* can vote on behalf of the group).

- Meeting Safety Task Force Group Representatives at the 2018 Fall Assembly approved a motion to "Create a A Task Force to Develop a Guideline or Procedure for groups when dealing with safety issues." The Task Force has drafted the "Rhode Island Al-Anon Family Group Meeting Safety Suggestions" which is included in this packet. GRs are asked to share this information with their groups prior to the Assembly. In support of this report, we also are including the WSO publication "Let's Talk about Safety in Al-Anon Meetings."

Remember, if the GR or Alternate GR cannot attend, the group can send a proxy\*. If a proxy is sent, he/she should bring a signed note from the group giving him/her permission to vote on behalf of the group.

#### From Providence & Points North

- o On Route 95 heading South take Exit 9 (on left) for Route 4 South.
- o On Route 4, take the first exit for Route 401, Division St, East Greenwich.
- o At top of exit go right onto Division St.
- o Follow Division St. for 1.2 miles to fork in road.
- o Take the left fork (still on Division St.) and go .8 miles further, taking the 6th right onto Peirce St.
- o St. Luke's is 4 blocks down on the corner of Peirce & Church Streets.
- o Parking lot is behind the church.

#### From Points East

- o Take RI-138 over the Newport and Jamestown Bridges
- o Exit onto US-1 N toward Providence
- O Use the left 2 lanes to turn slightly left onto RI-4 North
- o Take exit 8A for Route 401 Division St., East Greenwich
- Follow Division St. for 1.2 miles to fork in road.
- o Take the left fork (still on Division St.) and go .8 miles further, taking the 6th right onto Peirce St.
- o St. Luke's is 4 blocks down on the corner of Peirce & Church Streets.
- o Parking lot is behind the church.

## From Points South/West

- o On Route 95 North, take exit 8A for Route 2 South, East Greenwich.
- o At first stop light, take a left onto Division St. (Route 401)
- o Follow Division St. for 1.5 miles to fork in road.
- o Take the left fork (still on Division St.) and go .8 miles further, taking the 6th right onto Peirce St.
- o St. Luke's is 4 blocks down on the corner of Peirce & Church Streets.
- Parking lot is behind the church.

# What is an Assembly?

An Area Assembly is the business meeting where groups send their GR or other group appointed proxy to express a voice and vote on behalf of the group. Also in attendance are the District Representatives and the Area Officers and Coordinators. Any and all interested Al-Anon and Alateen members are encouraged to attend as well.

The Rhode Island Area has two Assemblies per year - Spring and Fall - where we discuss issues pertinent to our Area as well as issues our Delegate may bring to us from the World Service Conference and WSO. GRs hear reports from the Delegate and other Area Officers/Coordinators; elect new officers and coordinators; and review and vote on the Area budget, proposed Area policies and guidelines, and proposed changes to Area operations.

At the Assembly, the GRs and group appointed proxies are the only people who can vote on issues before the Assembly. In addition to voting at the Assembly, the GRs/proxies carry information from the group to the Assembly and back from the Assembly to their groups.



# What's NEWs in District II - March 2019 Meeting Report

Once a month, District II meets for about an hour at a named location to unite the individual groups within the district. Topics range from informing groups about Area or World Service news to planning program-related events. District meetings also coordinate service and public outreach projects and as such are a great way to see the program in action and get involved in service.

The March 2019 District II meeting was held at the North Kingstown Free Public Library. Because a lot of planning goes into hosting the Spring Assembly, that checklist was revisited FIRST to make sure all the necessary volunteer positions were covered (i.e., set-up and breakdown, registration, etc) and any lingering logistics were sorted out (i.e., Wi-Fi password and projector for the presentation, etc).

In addition, the Group Reps (GRs) were encouraged to continue sharing the date of the assembly with their groups – Saturday May 18<sup>th</sup> at St. Luke's Episcopal Church in East Greenwich – AND to ask their groups for potluck items. \*\*Should you feel called to do service, we are still in need of potluck items for the assembly and will gratefully accept your donations =)\*\* Simply bring your food donations to St. Luke's on May 18<sup>th</sup> between 8:30am-11:45am. We thank you in advance!

After discussing the organizational details of the assembly, district members revisited having the question put to the assembly about creating guidelines for task force chairs. The Area Coordinator brought a copy of a format she received from the delegate as an example to share and said that she would add this question to the upcoming assembly agenda. That agenda was discussed at the area meeting on April 6th at the Area Office in Cranston. In addition, it was also reported that the Do Not Refer/Re-Refer task force was ready to present at the assembly.

In new business, one GR brought a concern to the District about "unhealthy meetings" – groups that don't use the service manual or fill group positions and that use outside (non-conference approved) literature, etc. She asked the members to think about this and bring suggestions to the next meeting.

Also in new business, the Al-Anon/AA Liaison suggested making buttons as a possible "love gift" for the RI Delegate to bring to the World Service Conference. She brought a sample template for the button-making machine she'd ordered for the AA convention and shared that the process was quite easy to do. The group talked about other possible love gift ideas while noting how close it was to the date of the conference and that the delegate would be leaving April 10<sup>th</sup> for the conference. Although no definitive decision was made at the meeting, the Alternate District Rep asked that the template be sent to him to see if he could come up with something.

The discussion then turned to the Safety Meeting Task Force report. It was reported that the meeting went well and that the task force discussed devising a simple plan with bullet points; a preamble; questions; and suggestions on what groups might use, allowing knowledge-based decision-making (KBDM) to guide them. Their next meeting was on April 3<sup>rd</sup> at the Area Office in Cranston. Finally, it was mentioned that the Fall Workshop Coordinator position still needed to be filled. GRs were asked to get the word out at their groups, and the GRs asked that the flyer created with this information on it be forwarded to them again since most had not received it.

That wraps up this District II Report! Our next District Meeting will be held on **Thursday May 9th at 6:30pm at the North Kingstown Free Public Library** in the downstairs conference room. All are welcome to attend. If you are in District II and would like to host a future District Meeting, please contact your District Rep. We're happy to rotate the District meeting location each month in an effort to encourage participation and service.

Before meeting, the Committee created a dedicated email address and solicited safety suggestions from our members via *Lifelines* but did not receive any outside input.

The group met twice to determine what type of guidelines we wanted to create. We evaluated and compared safety guidelines from other Areas, as well as the recently issued World Service guidelines, which came out after the Fall Assembly. All formats and ideas were excellent and we especially favored the WSO guidelines, however, we all agreed they were too lengthy for the 21st century short-attention span reader. Our focus has been to create clear, simple RIAFG suggestions and reference the WSO guidelines for additional support. We created a large comprehensive draft which we are consolidating and finalizing within the next two weeks.

The Committee feels strongly that since our charter was formed by the Fall Assembly, the RIAFG suggestions should be presented at the Spring Assembly for acceptance and approval. We will share our final draft with the Area beforehand, however, our goal is to present it at the Spring Assembly for GR and the Area Officer approval before distributing it to our membership.

# **FORUM ARTICLE:**

# I Was Finally Able to Take Off My Armor

Growing up in an alcoholic home, I had to figure so much out for myself. As a result, I developed an arrogant, smug belief that I had all the answers. I felt that I was the one who had to keep things together. Once I left home, I was sure that I was prepared to take on the world and vowed to myself to live differently. I put on my coat of armor and it was going to take a miracle for me to reveal my true self to anyone - including myself.

I heard about Al-Anon during an internship I was completing for school and attended some Al-Anon and AA meetings as part of my assignment. My immediate thought was that my mom really needed to do this Al-Anon thing because it was clear that she was unhappy with my father's drinking. She went a few times, but did not see how Al-Anon could help her. After all, she didn't drink. She purchased one of the daily readers and felt that was enough for her.

Even though my alcoholic loved one became sober and started going to AA, I was more miserable than ever. My deep-seated insecurities were running amuck, and by the time I got back to Al-Anon, I didn't think I belonged because I didn't want to belong. I didn't want to see my part. Fortunately, I head that Al-Anon was about my disease. My behavior and attitudes were making me sick and I didn't even realize it. I put everyone else first, thought I knew the answers to everyone else' problems, and justified my actions to the point that I didn't think I could change.

By listening to others share their experiences, I felt hope for myself - hope that I could risk taking off the armor, or maybe just a piece of it, to reveal the real me. Amazingly, I started to change as this loving program began to unfold in front of me. Al-Anon has helped me love and accept myself as I am, despite the family disease of alcoholism. I will "Keep Coming Back" to remind myself that I am worthy.
